Steve RawlingsSenior Port Development Manager



This role involves identifying areas where attention is needed and infilling those areas with staff or external consultants as required to ensure that the project moves forward and that design issues are identified, logged and allocated wherever possible.

They are supported by a team of designers, surveyors and administration staff who together are working hard to ensure the project runs smoothly and delivers for Dover.

Detailed information on progress

Bathymetric Survey

A bathymetric survey has been completed by the inshore survey vessel "Wessex Explorer" (opposite). The survey consists of a bathymetric survey to establish accurate seabed levels in the Western and Eastern Docks; a side scan sonar survey to identify seabed features in the Western Docks; a magnetometer survey to identify metallic items on the seabed such as unexploded ordnance, chains, wrecks, anchors, cabling etc; and a sub-bottom profile to identify the level of silt and chalk so that the volume of areas to be dredged can be established.



Forthcoming



- Tender notices for the marine civil engineering package have been posted in the European Journal and interest from major civil engineering contractors has been high. A number of contractors competing for the tender have been shortlisted.
- In order to get to the point where there is sufficient information to complete a detailed design it is essential to have an understanding of the existing structures, seabed levels and the geology underlying the Port in the areas of construction.
- A ground investigation has been commissioned to ensure that the most cost effective design solution is chosen and that the risk of unknown ground conditions being encountered is minimised (opposite). The commission should be completed by the end of May.

We thank all of our customers and community for their understanding, co-operation and support as our work to revive the Western Docks continues.
